Planning Committee Update – Approve Zoning Ordinance Change: For the health of the lake, proposed changes allow cars to be parked on the renter’s property with one space available for each bedroom. A representative from the Lake Wapogasset/Bear Trap association requested a letter from the Town detailing support and contributions to the boat cleaning project. Town will send support letter for excavation, labor, and assist with construction in spring in an amount of \$2200 in kind support. Lake Association will take care of maintenance and pumping of the boat cleaning machine. Town needs to draw up a land use agreement when the grant is approved.
